





The Fund aims to grow in value by more than the FTSE All-Share Index by generating a growing level of income, together with investment growth over a three to five-year period after all fees and costs are deducted.



Objective

The Fund aims to provide capital growth over the long term (5 years or more) by investing in companies whose products and services are considered by the Investment Manager as contributing to positive environmental or social change.

Investment policy

INVESTMENT OBJECTIVE





Investment process



Objective and investment policy

The fund aims to provide:

- a combination of capital growth and income to deliver a return, net of the Ongoing Charge Figure, that is higher than that of the MSCI ACWI Index over any five-year period; and
- an income distribution that increases every year in sterling terms.

Core investment: At least 80% of the fund is invested in the shares of infrastructure companies, investment trusts and real estate investment trusts of any size, from anywhere in the world, including emerging markets. 

We aim to deliver a greater total return than the Investment Association (IA) Sterling Corporate Bond sector, after fees, over any rolling five-year period. Total return means the return we receive from the value of our investments increasing (capital growth) plus the income we receive from our investments (interest payments). We use the IA Sterling Corporate Bond sector as a target for our fund's return because we aim to achieve a better return than the average of funds that are similar to ours.

We will invest at least 80% of our fund in corporate bonds with an investment-grade rating (AAA to BBB-), based on the average of the three largest rating agencies (Standard & Poor's, Moody's and Fitch). 








